Weingarten Rights

Legally protected rights to union representation.

- Invoke this right for any meeting involving the following:
 - Teacher discipline
 - Investigation of any sort
 - Reprimand
 - Infraction of work rule/ board policy
 - Questions about leave/leave requests
 - Allegations of abuse
 - Parent/ student/ community complaints

If asked to attend a meeting with a principal or supervisor and you request representation, the meeting must be scheduled at a time a rep is available.

Weingarten Rights

"If the discussion I am being asked to enter into could in any way lead to my discipline or termination or affect my personal working conditions, I ask that a union representative or officer be present with me at the meeting. Without representation, I choose not to answer any questions. This is my right under a U.S. Supreme Court decision called Weingarten."

What to do if an issue arises

Address it ASAP. Step 1—Look it up in the contract Step 2—Talk to your administrator Step 3—Talk to your building rep Step 4—Talk to your union president Step 5—Talk to your Labor Relations Consultant Kerri Hoover (hooverk@ohea.org) Step 6—File grievance, unfair labor practice, etc. Don't skip this step! An administrator can't do anything to fix your problem if he/she doesn't know there is one.

Insurance Reminders

Four steps to help control costs and keep premiums down:

1. For regular prescriptions, use the **mail-in service** (3 months). For other prescriptions, go **generic** whenever possible; the UHC website can help you find generic equivalents or ask your pharmacist.

2. **Only use the ER for emergencies**. For non-emergencies, use your family doctor or urgent care clinics.

3. Be sure you have a **family doctor** and visit him/her when you have issues as well as regularly for **preventative care**.

4. Make use of **UHC's Care24 hotline (1-888-887-4114)** and the resources available on the **UHC website**.

Memorandum Of Understanding

- Teachers will get 210 minutes of planning time during TEACHER work day.
